ACKNOWLEDGEMENT OF RISK, WAIVER AND RELEASE OF LIABILITY
WARNING: THIS AGREEMENT WILL AFFECT YOUR LEGAL RIGHTS. READ IT CAREFULLY!

IN CONSIDERATION of the undersigned participant (the "Participant") being permitted to enter upon the land, facilities, or premises (the "Premises") being used for the Charity Golf Classic (CGC), presented by McDonald's Restaurants of Central Alberta and/or the privilege of participating, competing, officiating, observing, and/or volunteering in the CGC (collectively, the "Participation"), this Acknowledgement of Risk, Waiver and Release of Liability ("Waiver") is entered into by the Participant for the benefit of

- (i) Ronald McDonald House Charities® Southern & Central Alberta and the Southern Alberta Pediatric Hostel Society;
- (ii) sponsors, promoters or advertisers of the CGC;
- (iii) any and all advisors, consultants, including but without limitation, Innisfail Golf Club, volunteers or paid workers assisting CGC activities; (iv) other participants in CGC;
- (v) owners, operators and lessees of the Premises;
- (vi) underwriters, insurers and others involved in risk evaluation related to CGC; (vii) any other beneficiaries or parties that may benefit from CGC or the funds raised thereby; and
- (viii) the respective directors, officers, shareholders, members, agents, servants, employees or representatives of each of the foregoing (all or any of which persons are collectively referred to as the "CGC Parties").

The Participant:

1. waives any and all claims of any type or nature that the Participant has or may in the future have against, and release and forever discharge from all liability and agree not to sue, any of the CGC Parties for or from any injury, loss or damage sustained by the Participant (including death) and/or property damage (including loss of use) and any consequential or other losses or damages, in any case, howsoever caused, including, without limitation, whether caused by negligence, gross negligence, breach of contract, breach of any legal duty, mistakes or errors of judgment in any way related to the Participant's or anyone else's Participation.
2. is aware that there are serious hazards, risks and dangers (collectively, "The Risks") associated with Participation that involve risk of serious injury to the Participant (including death) or damage to property including, but not limited to, the following:
 - while there will be Rules and Regulations to participating in the CGC that are aimed at reducing physical contact and risk of injury
 - participants in golf use clubs and a ball which, whether intentional or unintentional, may cause physical injury
3. agrees to hold harmless and indemnify the CGC Parties and each of them from any and all actions, proceedings, claims, damages, costs, demands, including court costs and costs on a solicitor and own client full indemnity basis, and liabilities of whatsoever nature and kind arising out of or in any way connected with the Participation of the Participant.
4. acknowledges and confirms that the Participant is familiar with the Premises and knows and consents to the Risks and acknowledges that the CGC Parties or any of them are not responsible for or under any obligation to place the Premises in any other condition other than what now exists so as to ensure the Participant's safety while thereat or thereon and that while the CGC Parties have taken steps to reduce the Risks, it is not possible for the CGC Parties, or any of them, to make the Participation safe. The Participant accepts these Risks and agrees to the terms of this Waiver even if any of the CGC Parties are found to be negligent or in breach of any duty of care or any obligation in respect of the Participation by the Participant.
5. acknowledges and agrees that the Participant is not relying upon any oral, written or visual statements of any kind, inducements, promises or representations in respect of any matter relating to the CGC or the Premises in connection with the Participation of the Participant or the execution hereof.
6. agrees that this Waiver and all terms contained herein are governed exclusively in all respects by the laws of the Province of Alberta, Canada. The Participant hereby irrevocably submits to the exclusive jurisdiction of the courts of the Province of Alberta and agrees that no other court can exercise jurisdiction over the terms and claims referred to herein.
7. in executing this Waiver, confirms that the Participation of the Participant in the CGC is voluntary, the Participant agrees to Participate in the CGC in accordance with all the application Rules and Regulations, which Rules and Regulations have been read and understood by the Participant and the undersigned Guardian, if applicable.
8. acknowledges and confirms that the CGC that this Waiver applies to any and all activities at the CGC.
9. is over the age of 18 years of age or, if the Participant is younger than 18 years of age, the age of the Participant is set forth below and the legal Guardian of the Participant is also a signatory hereto and such Guardian hereby authorizes the Participant to participate in CGC and agrees to be responsible for the Participation of the Participant.

10. agrees that the provisions of this Waiver shall survive the Participation of the Participant in the CGC and shall be binding upon the Participants heirs, executors, administrators and other personal representatives.

11. grants permission to Event Organizers to use or authorize others to use any photographs, motion pictures, or any other record of participation in this event or related activities without remuneration. Applications for minors shall be accepted only with a legal guardian's signature and should be signed by the minor.

I HAVE READ THIS ACKNOWLEDGEMENT OF RISK, WAIVER AND RELEASE OF LIABILITY AND FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
